ARTICLE 3: To see if the Town will appropriate $\$ 65,000$ from the Unassigned Fund Balance, which appropriation shall carry over into FY 23-24 and authorize the Select Board to expend said funds during FY 23-24 to engage the Certified Public Accountant Services of Berry, Talbot and Royer.

Dennis Long made motion to approve article as written; seconded by Joyce Bakshi. Article Passed as Written.

ARTICLE 4: To see if the Town will vote to appropriate a total of $\mathbf{\$ 8 5 , 0 0 0}$ from the Unassigned Fund Balance. Up to $\mathbf{\$ 5 5 , 0 0 0}$ will be used to ratify the overdrafts in District One and District Two Winter Maintenance Accounts for FY22. After the ratification, $\mathbf{\$ 1 5 , 0 0 0}$ will be placed in the District One FY22 Winter Maintenance Account and $\mathbf{\$ 1 5 , 0 0 0}$ will be placed in District Two FY22 Winter Maintenance Account. Any unexpended funds, in either Winter Maintenance Account, as of $06 / 30 / 2023$ will be returned to the Unassigned Fund.
