## **ARTICLES 12 AND 13 RAISE FUNDS FOR THE PROPOSED SCHOOL BUDGET**

### **ARTICLE 12**

To see what sum the municipality will appropriate for the total cost of funding public education from kindergarten to grade 12 as described in the Essential Programs and Services Funding Act **\$3,939,348** and to see what sum the municipality will raise as the municipality's contribution to the total cost of funding public education from kindergarten to grade 12 as described in the Essential Programs and Services Funding Act in accordance with the Maine Revised Statutes, Title 20-A, section 15688.

**School Committee recommends: \$3,837,025**

*“Explanation: The school department’s contribution to the total cost of funding public education from kindergarten to grade 12 as described in the Essential Programs and Services Funding Act is the amount of money determined by state law to be the minimum amount that a municipality must raise in order to receive the full amount of state dollars.”*

**Warrant and Finance Committee Recommends: \$3,837,025**

**Judy Shain made a motion to approve the article as recommended by the School Committee in the amount of \$3,837,025.**

### **ARTICLE 13**

**(This Article requires a written Ballot)**

To see what sum the municipality will raise and appropriate in additional local funds (**Recommend \$1,148,223**) that exceeds the state’s Essential Programs and Services allocation model by (**Recommend \$1,060,389**) as required to fund the budget recommended by the School Committee.

The School Committee Recommends **\$1,148,223** for additional local funds and gives the following reasons for exceeding the State’s Essential Programs and Services allocation model by **\$1,060,389**: The Essential Programs and Services allocation model does not fully support all the costs of a K-12

program. These funds support programming not included in the Essential Programs and Services Model.

*Explanation: The additional local funds are those locally raised funds over and above the school department's local contribution to the total cost of funding public education from kindergarten to grade 12 as described in the Essential Programs and Services Funding Act and local amounts raised for the annual payment of non-state funded debt service that will help achieve the Acton School Department budget for educational programs.*

**Judy Shain made a motion to approve the article as recommended by the School Committee in the amount of \$1,148,223. Seconded by Mary Station.**

## **ARTICLE 14 SUMMARRIZES THE PROPOSED SCHOOL BUDGET**

### **ARTICLE 14**

To see what sum the Town of Acton will authorize the School Committee to expend for the fiscal year beginning July 1, 2010 and ending June 30, 2011 from the School Department's contribution to the total cost of funding public education from kindergarten to grade 12 as described in the Essential Programs and Services Funding Act, non-state funded school construction projects, additional local funds for school purposes under the Maine Revised Statutes, Title 20-A, section 15690, unexpended balances, tuition receipts, state subsidy and other receipts for the support of schools.

**School Committee recommends: \$5,087,571**

*Explanation: This article is a summary article and approves expenditures of the proposed budget of \$5,087,571. This article authorizes the School Committee to spend the money appropriated in the previous articles, plus other revenues. The article does not raise any additional money.*

**Warrant and Finance Committee Recommends: \$4,861,449**

**Judy Shain made a motion to approve the article as recommended by the School Committee in the amount of \$5,087,571. Seconded by Bill Lotz.**
