ARTICLE 13: To see what sum the municipality will appropriate for the total cost of funding

public education from kindergarten to grade 12 as described in the Essential Programs and Services Funding Act \$3,432,619.25 and to see what sum the municipality will raise as the municipality's contribution to the total cost of funding public education from kindergarten to grade 12 as described in the Essential Programs and Services Funding Act in accordance with the Maine

Revised Statutes, Title 20-A, section 15688.

School Committee Recommends: \$3,128,593

Warrant and Finance Committee Recommends: Unanimously Raising \$3,128,593 and

Appropriating \$3,432,619

"Explanation: The school department's contribution to the total cost of funding public education from kindergarten to grade 12 as described in the Essential Programs and Services Funding Act is the amount of money determined by state law to be the minimum amount that a municipality must raise in order to receive the full amount of state dollars."

Judy Shain made a motion to raise \$3,128,593 and appropriate \$3,432,619 as recommended by the Warrant and Finance Committee; seconded by Mary Stanton. Motion carried. Article Passed.

ARTICLE 14:

(This Article requires a written Ballot)

To see what sum the municipality will raise and appropriate in additional local funds (Recommend \$1,662,445) that exceeds the state's Essential Programs and Services allocation model by (Recommend \$2,022,267) as required to fund the budget recommended by the School Committee.

The School Committee Recommends:

\$1,662,445 for additional local funds and gives the following reasons for exceeding the State's Essential Programs and Services allocation model by \$2,022,267: The Essential Programs and Services allocation model does not fully support all the costs of a K-12 program. These funds support programming not included in the Essential Programs and Services Model.

The Warrant and Finance Committee Recommends:

Unanimously that the Town raise and appropriate \$1,662,445 in excess of the Essential Programs and Services (hereinafter called EPS) minimum to cover the costs of kindergarten, the school nutrition program, high school student transportation and other programs and services not included in the EPS model.

Explanation: The additional local funds are those locally raised funds over and above the school department's local contribution to the total cost of funding public education from kindergarten to grade 12 as described in the Essential Programs and Services Funding Act and local amounts raised for the annual payment of non-state funded debt service that will help achieve the Acton School Department budget for educational programs.

Judy Shain made a motion to raise and appropriate \$1,662,445 that exceeds the State's Essential Programs and Services allocation model by \$2,022,267 as recommended by the School Committee; seconded by Mary Stanton. Article 14 was voted on by written secret ballot 43-3; motion carried. Article Passed.

ARTICLE 15 SUMMARIZES THE PROPOSED SCHOOL BUDGET

ARTICLE 15:

To see what sum the Town of Acton will authorize the School Committee to expend for the fiscal year beginning July 1, 2015 and ending June 30, 2016 from the School Department's contribution to the total cost of funding public education from kindergarten to grade 12 as described in the Essential Programs and Services Funding Act, non-state funded school construction projects, additional local funds for school purposes under the Maine Revised Statutes, Title 20-A, section 15690, unexpended balances, tuition receipts, state subsidy and other receipts for the support of schools.

Explanation: This article is a summary article and approves expenditures of the proposed budget of \$5,220,860. This Fund is used for purposes of covering unexpected new residents moving in with high school students, home school students deciding to attend charter schools or the high school and new residents with students having special needs.

This Fund is used for purposes of covering legal and other professional services for unpredicted legal issues.

ARTICLE 22 ESTABLISHES THE HEALTH RESERVE FUND AND AUTHORIZES A TRANSFER TO AND EXPENDITURE FROM THAT FUND

ARTICLE 22:

To see if the Town of Acton will vote to create a Designated Health Reserves Fund, to transfer \$15,000 from the School Undesignated Fund to the Designated Health Reserve Fund and to authorize the expenditure of funds from that Reserve Fund. This Fund is used for purposes of covering employee health insurance changes, including marriage, new family, etc. This may be used to cover any penalties charged due to the Affordable Care Act.

ARTICLE 23 ESTABLISHES THE SECURITY AND SAFETY UPGRADES RESERVE FUND AND AUTHORIZES A TRANSFER TO AND EXPENDITURE FROM THAT FUND
