**(C) BIG DADDY LIQUOR LICENSE:** Mr. Hannon had requested that a hearing be waived but selectmen did not agree. The date of March 26, 2009 at 7 pm was set for the public hearing. Tony stated he wants a report from the Sheriff Department, the Maine State Police, fire inspection, code inspection and health inspection before the hearing is held.
