1.4.11.4 Relocation – A non-conforming structure shall be relocated within the boundaries of the parcel on which the structure is located provided that the site of relocation conforms to all setback requirements to the greatest practical extent as determined by the Planning Board, and provided that the applicant demonstrates that the present subsurface sewage disposal system meets the requirements of State Law and the State of Maine Subsurface Wastewater Disposal Rules or that a new system can be installed in compliance with the law and said Rules. In no case shall a structure be relocated in a manner that causes the structure to be more non-conforming. In determining whether the building relocation meets the setback to the greatest practical extent, the Planning Board shall consider the size of the lot, the slope of the land, the potential for soil erosion, the location of other structures and utilities with associated easements on the property and on adjacent properties, the location of the septic system and other on-site soils suitable for septic systems, and the type and amount of vegetation to be removed to accomplish the relocation. The Planning Board shall not consider any improvements to the property that have occurred within the preceding five (5) years. A building permit must be obtained within eighteen (18) months of Planning Board approval.

1) No part of any extraction operation shall be permitted within ~~one~~ three hundred (~~100~~ 300) feet of any property or street line, except the drainage ways to reduce run-off into or from the extraction area may be allowed up to fifty (50) feet of such line. Natural vegetation shall be left and maintained on the undisturbed land.

9) Natural vegetation shall be retained within ~~100~~ 300 feet of the property line or street line. The Planning Board may require the applicant to provide screening, a berm, or a combination where the natural buffer is inadequate. A 25-foot natural buffer will be maintained from any wetlands of ¼ acre to 2 acres, as determined by a credentialed professional.

Explanation: "The school department's contribution to the total cost of funding public education from Prekindergarten to grade 12, as described in the Essential Programs and Services Funding Act, is the amount of money determined by state law to be the minimum amount that a municipality must raise to receive the full amount of state dollars."
